Applications are invited from the eligible Indian citizen as defined in Article 5 to 8 of the Constitution of India and permanent residents of Assam for filling up 7500 vacant posts of (1) Graduate Teachers (Arts), (2) Graduate Teacher (Science), (3) Graduate Teacher (Hindi) and (4) Graduate Teacher (Sanskrit) of the different Provincialised Secondary Schools under the Directorate of Secondary Education, Assam in the scale of pay of Rs.14,000 /- to 70,000 /- including Grade Pay of Rs. 8,700 /- PM (under pay band II) plus other allowances as admissible under rules.

The District-wise, subject-wise, medium-wise and category-wise posts details as well as date and time of receipt of online applications and other details will be notified in the official website at www.madhyamik.assam.gov.in in due course of time. Vacancies may vary due to administrative reasons. The Director of Secondary Education, Assam reserves the right to make changes in sequence of the recruitment process after publication of this advertisement.

The Director of Secondary Education, Assam reserves the right to cancel or postpone the recruitment at any stage without assigning any reason.

The aspiring candidates must be ready to serve in their respective places of posting in terms of choice of their Districts.

> CONDITIONS OF RECRUITMENT:-

(A) Minimum educational and professional qualifications for direct recruitment in the post of Graduate Teacher (Arts & Science).

- For the post of Graduate Teacher (Arts), the candidate must be Arts / Commerce Graduate or
 Post Graduate in Arts / Commerce having from recognized University with at least 50% marks
 in either Graduation or Post Graduation (or its equivalent) and Bachelor of Education (B.Ed.)
 from National Council for Teacher Education recognized Institution(s).
- 2. For the post of Graduate Teacher (Science), the candidate must be Science Graduate or Post Graduate in Science having from recognized University with at least 50% marks in either Graduation or Post Graduation (or its equivalent) and Bachelor of Education (B.Ed.) from National Council for Teacher Education recognized Institution(s).
- 3. In pursuance of the Govt. OM No. ASE.238/2014/213, dtd. 22.11.2019, those institutions having territorial jurisdiction outside the State of Assam but having a study centre in the State and such study centres if not recognized by DEC under UGC, the degrees / certificates issued by such off campus institutions shall not be considered as valid for the purpose of employment under Education Department. However, degrees / diplomas conferred by KKHSOU, IGNOU, IDOL under Gauhati University and Distance Education under Dibrugarh University shall be considered as valid for the purpose of employment.
- 4. In respect of Secondary TET Candidate must obtain 60% marks in each paper for UR category and 55% marks for OBC/MOBC, SC, ST(P), ST(H) and PwD category.

(B) Minimum educational and professional qualifications for direct recruitment in the post of Graduate Teacher (Hindi).

 Pravin / Ratna in Hindi with 50% marks and degree qualification with 50% marks or post Graduate degree in Arts with 50% marks from any recognized University,

Or

BA with 50% marks and having Hindi as one of the subjects with 50% marks or post Graduate in Arts with 50% marks provided that he has passed BA with one of the subjects as Hindi with 50% marks in Hindi

- B.T. / B.Ed. degree from any recognized University (PARANGAT to be treated as B.Ed. degree only for the purpose of Hindi teaching).
- 3. In pursuance of the Govt. OM No. ASE.238/2014/213, dtd. 22.11.2019, those institutions having territorial jurisdiction outside the State of Assam but having a study centre in the State and such study centres if not recognized by DEC under UGC, the degrees / certificates issued by such off campus institutions shall not be considered as valid for the purpose of employment under Education Department. However, degrees / diplomas conferred by KKHSOU, IGNOU, IDOL under Gauhati University and Distance Education under Dibrugarh University shall be considered as valid for the purpose of employment.
- In respect of Secondary TET Candidate must obtain 60% marks in each paper for UR category and 55% marks for OBC/MOBC, SC, ST(P), ST(H) and PwD category

(C) Minimum educational and professional qualifications for direct recruitment in the post of Graduate Teacher (Sanskrit).

 Shastri with 50% marks and having degree qualification with 50% marks or post Graduate degree in Arts with 50% marks from any recognized University,

Or

BA with 50% marks and having Sanskrit as one of the subjects with 50% of marks or Post Graduate Degree in Arts with 50% marks in Sanskrit.

- 2. B.T. / B.Ed. degree from any recognized University.
- 3. In pursuance of the Govt. OM No. ASE.238/2014/213, dtd. 22.11.2019, those institutions having territorial jurisdiction outside the State of Assam but having a study centre in the State and such study centres if not recognized by DEC under UGC, the degrees / certificates issued by such off campus institutions shall not be considered as valid for the purpose of employment under Education Department. However degrees / diplomas conferred by KKHSOU, IGNOU, IDOL under Gauhati University and Distance Education under Dibrugarh University shall be considered as valid for the purpose of employment.
- In respect of Secondary TET Candidate must obtain 60% marks in each paper for UR category and 55% marks for OBC/MOBC, SC, ST(P), ST(H) and PwD category

In addition to the academic and professional qualification as per sub-rule 10 (5) Sub-Rule 1 (i) to (v) of the Assam Secondary Education (Provincialised Schools) Service Rules of 2018, the candidate must satisfy the following criteria:-

(i) In case of Assamese Medium School, the candidate must have passed HSLC or equivalent Examination with Assamese Language as one of the subjects or have Diploma in Assamese Language issued by the Axom Sahitya Sabha or read up to HSLC level in Assamese medium School.

- (ii) In case of Bengali Medium School, the candidate must have passed HSLC or equivalent examination with Bengali language as one of the subjects or have Diploma in Bengali language issued by the Barak Upatyaka Bangya Sahitya O Sanskriti Sammelan or read up to HSLC level in Bengali medium School.
- (iii) In case of Hindi medium School, the candidate must have passed HSLC or equivalent Examination with Hindi language as one of the subjects or read up to HSLC level in Hindi medium School.
- (iv) In case of Bodo Medium School, the candidate must have passed HSLC or equivalent Examination with Bodo language as one of the subjects or read up to HSLC level in Bodo Medium School.
- (v) In case of English Medium School, the candidate must have passed HSLC or equivalent Examination with Alternative English as one of the subjects or read from Class XI onwards in English Medium School.

Provided that for recruitment of teacher for teaching MIL subject, the candidate who passed HSLC examination with particular MIL subject shall be considered.

(a) Criteria for Selection of Graduate Teacher (Arts and Science):

- 100 marks on percentage of marks in B.A/B.Com/B.Sc examination (in case of Major/Hons, the marks obtained in Major/Hons shall be taken into consideration).
- II. 100 marks on percentage of marks in HS final examination.
- III. 100 marks on percentage of marks in B.T./B.Ed. final examination.
- IV. 100 marks on percentage of marks in TET examination or 60 marks for 15 years of experience as an undergraduate/Junior Teacher in a provincialized High/Higher Secondary school having requisite academic and professional qualification. Any experience teacher who has appeared but could not secure the minimum qualifying 60 marks in the TET, shall be awarded at least 60 marks in respect of their experience if he or she has already completed 15 years of teaching experience. Any marks secured by such experienced teacher over and above 60 qualifying marks in TET shall be counted additionally in respect of TET for such teacher.
 - V. Explanation: For the purpose of calculation of marks under the categories mentioned in clauses (i)(ii), (iii) and (iv) above it may be clarified that if a candidate secures; for example 60% marks in the particular examination he/she secure 60 marks out of 100 marks allotted in the concerned examination.
- VI. 50 marks @ 25 marks for one year of teaching experience as contractual teacher and another 25 marks for two years, subject to consideration for a minimum period of two years.

The Rule 10 (3) of the Assam Secondary Education (Provincialised Schools) Service Rules, 2018 prescribes that:-

"The teachers engaged on contractual basis in a provincialised Higher Secondary / High school under the Scheme "strengthening of secondary education" shall be given preference for recruitment to the post of Graduate Teacher by awarding total 50 bonus marks for their services as contractual teacher, i.e. 25 marks for one year and another 25 marks for completion of two years of service as contractual teacher, subject to consideration for maximum period of two years".

- VII. 50 marks teaching experience for the teachers working continuously on fixed pay basis (other than contractual teachers) in a provincialized Higher Secondary School or High School/Madrassa for their service as fixed pay teachers provided they have requisite academic and professional qualification.
- VIII. 10 marks for NCC certificate (10 marks for "C" certificate and 5 marks for "B" certificate)
 - IX. 10 marks for participating in recognized sports at national level representing Assam.
 - X. 10 marks for achievements in fine Arts and cultural activities representing the State officially at National level.

(b) Criteria for Selection (1) Graduate Teacher (Hindi) and (2) Graduate Teacher (Sanskrit):

- 100 marks on percentage of marks in BA Examination with the concerning language as I. one of the subjects or highest degree in the language i.e. Pravin / Ratna Examination in case of Hindi Teacher or in Shastri Examination in case of Sanskrit Teacher.
- 100 marks on percentage of marks in HS final examination. П.
- 100 marks on percentage of marks in B.T./B.Ed. final examination. Ш.
- 100 marks on percentage of marks in TET examination; provided that a special TET shall IV. be conducted for language teachers comprising of the subjects of Pedagogy and Child Development, Language concerned and General Knowledge.
 - 10 marks for NCC certificate (10 marks for "C" certificate and 5 marks for "B" V. certificate)
- 10 marks for participating in recognized sports at national level representing Assam. VI.
- 10 marks for achievements in fine Arts and cultural activities representing the State VII. officially at National level.
- N.B. In all the above mentioned category of teachers, any other marks obtained in any other examinations such as HSLC or equivalent, Graduation / BT or B.Ed. and any other professional qualification not recognized by UGC / NCTE guidelines / Service Rules, in vogue will not be considered.

Other Criteria

- 1. District-wise, Medium-wise, Subject-wise separate Merit Lists will be prepared for each category of the post.
- 2. A candidate must not be less than 18 years of age and not more than 40 years for unreserved category, 42 years for Ex-Servicemen, 43 years for OBC/ MOBC and 45 years for SC/ ST(P)/ST(H) and 50 years for Persons with Disability (PwD) as on $\underline{1}^{st}$ January, 2022 as per Govt. Office Memorandum vide No. ABP.6/2016/51 Dated 02/09/2020 and subsequent Corrigendum No. ABP.6/2016/52, dtd. 20.02.2021.
- 3. No person having more than two living children on or after 01/01/2021 from a single or multiple partners shall be eligible for appointment as per the Govt. policy on Small Family Norms, the Guidelines contained in the Notification No. ABP.69/2019/17 dated 06/11/2019 and No. ABP.69/2019/18 dated 16/11/2019.
- 4. No offline application will be accepted in this regard.
- 5. The Online Applications and documents submitted by the candidates will be verified along with their original testimonials, by the District Selection Committee (DSC). The District-wise detailed schedule and venue for Screening/ Verification of documents will be notified in the official website. No TA/DA is admissible for verification process. District wise verification will be conducted simultaneously on the same date and time in the Districts by the respective DSC. Candidates will be informed either individually by the respective Inspector of Schools or collectively by the Director of Secondary Education, Assam in the official website.
- 6. The Online Applications and documents submitted by the candidate will be verified using modern technology with the help of DigiLocker, Govt. of India and by scanning Barcode or QR Code for ensuring genuineness of the uploaded documents as well as by back office verification with the competent board/ council/ authority. But the authority if desires may conduct physical document verification at any point of time with proper
- 7. The candidate must ensure genuineness of all the information/ documents uploaded against the online application and he/ she will be solely responsible for the information/ documents uploaded against his/ her online application. Once uploaded there will be no scope of correction in respect of the credential submitted by the candidate. Any discrepancy will lead to cancellation of the candidature.
- 8. The candidature will be cancelled forthwith, if any kind of fraudulence/ discrepancy regarding any information / documents uploaded by the candidate is established by appropriate authority at any point of time. The candidate will be debarred from any future recruitment under Government of Assam and subsequent legal action will also be initiated against such candidate.

- A candidate will mention and select the name of the districts for which the application is submitted.
- 10. When the candidates appear for the verification before the DSC they must produce original certificates, testimonials and documents that was uploaded during the application stage.
- 11. Physical fitness as per Rule 11 of the Assam Secondary Education (Provincialised Schools) Service Rules, 2018:-

A candidate for direct recruitment shall be :-

- (a) of sound health both mentally and physically and freee organic defect or bodily infirmity which is like to interfere with the efficient performance of his duties and
- (b) required to undergo medical examination before appointment to the service.
- The Madrassa TET and Special TET for BTAD / Sixth Schedule shall not be considerd in the the recruitment process of Graduate Teacher ARTS / SCIENCE / HINDI / SANSKRIT.
- 13. The candidates having NOT CLEAR (NC) status against any qualification will not be eligible to apply.
- 14. There shall be reservation for OBC / MOBC / SC / ST(P) / SH(H) / PWD / WOMEN / EX-SERVICEMEN etc., as per existing Government Rules.

- 13. Experience certificate (if any) of 15 years of teaching experience in undergraduate/junior teacher in provincialized High / Higher Secondary School.
- 14. Experience certificate (if any) 1(one) year of teaching experience as contractual teacher.
- 15. Experience certificate (if any) 2(two) years of teaching experience as contractual teacher.
- 16. Experience certificate (if any) of teaching experience for the teachers working continuously on fixed pay basis(other than contractual teachers) in a provincialized Higher Secondary School or High School / Madrassa for their service as fixed pay teachers provided they have requisite academic and professional qualification.(As per applicable, if any).
- 17. Certificate of Ex-servicemen issued by the Director, Sainik Welfare Board.

Please Note:

- a. Candidates should be cautious while submitting the online application as once the application is submitted against a particular Roll Number of TET, they will not be allowed to re-submit any online documents or application for the second time.
- b. After successful submission of the online form, candidates shall take a print out of the form and submit the same along-with self-attested copies of mark-sheets and certificates in support of educational qualification, caste, disability, TET, B.Ed. and co-curricular activities at the time of document verification before the District Selection Committee. Candidates must also produce original documents that have been uploaded with the online application to the DSC etc.
- c. After submitting the online application form, the candidates will get a Unique Number against the submitted application and will keep the printout of the unique Number for all future references.
- d. Candidates may note that failing to qualify in Screening/ Verification of documents will result cancellation of their candidature.
- e. The office will not be responsible for any lapse in submission of online application due to any technical problem.
- f. Application seeking condonation / relaxation of any criteria should be made to appropriate authority as per applicable norms at least 7 days prior to filling up of online applications
